

ACFA PRESIDENT (2006)

1. CHAIRS THE "BOARD" (ALL 4 OFFICERS, 8 CHAIRMEN, AND THE ADVISOR).
2. CALLS BOARD MEETINGS WHEN AND AS REQUIRED. (USUALLY ONE IN EARLY JAN. BEFORE THE FIRST MEETING IN FEB. AND POSSIBLY ONE ADDITIONAL AS SITUATION DICTATES.
3. RUNS THE MONTHLY MEETINGS UTILIZING A PRE-PREPARED WRITTEN AGENDA.
4. SETS/APPROVES THE YEARLY CLUB CALENDAR CONSISTING OF 11 MONTHLY MEETING DATES (1ST THURS, FEB — DEC) AND 8 MONTHLY TOURNAMENT DATES (MAR. — OCT.) [WATCH OUT FOR CONFLICTS SUCH AS 4TH OF JULY ON TNU]
5. APPOINTS NOMINATING COMMITTEE, BY SEPT. MEETING, FOR NOMINATIONS IN OCT., AND VOTING IN NOV. (FOR ALL POSITIONS.)
6. APPOINTS SPECIAL COMMITTEE CHAIRMEN AS/IF REQUIRED.
7. OVERSEES ALL BOARD PERSONS BY CHECKING WITH THEM FROM TIME TO TIME. ASSISTS V.P. IN LINING UP MONTHLY SPEAKERS.
8. CONTRIBUTES A SHORT "MESSAGE FROM THE PRESIDENT" FOR EACH MONTHLY NEWSLETTER, OR A SHORT RELATED ARTICLE FROM ELSEWHERE THAT HELPS SET THE TONE/PACE OF ACFA. TRANSMITS THIS MESSAGE (EACH MONTH) TO THE ~~X~~ NEWSLETTER EDITOR FOR INCLUSION IN THE NEWSLETTER.
9. HAS FINAL DECISION ON ALL MAJOR CLUB ACTIVITIES, USING ANY VOTE BY THE MEMBERSHIP AT ANY MEETING AS A GUIDE ONLY. THE BOARD MAY BE POLED FOR THEIR INPUT, AND ALL MAJOR DECISIONS FOR ACFA SHOULD HAVE MAJORITY BOARD APPROVAL.
10. ATTEMPTS TO FOCUS ON THE "BIG PICTURE" AND OVERALL DIRECTION OF THE CLUB DURING THE ENTIRE YEAR SO THAT ACFA THRIVES AND CONTINUES TO GROW.
11. IS SIGNATORY ON CLUB BANK ACCOUNT.
